Record of Decisions

This document is a preliminary working paper for the use of the Governing Body and officials of the Office. It records only the Governing Body's decisions, and not the circumstances of their adoption, except where they were the result of a formal vote. The comments or reservations by individual members or groups subject to which the decisions were made will be found in the minutes of the session.

Where an Office publication or paper refers to a Governing Body decision, the source given should be the relevant Governing Body document and minutes, and not this Record of Decisions.

The Record of Decisions is arranged in the order of the items on the Governing Body's agenda. All decisions relating to a particular paper or section of a paper are grouped together. After the decision the sitting at which it was taken is indicated in brackets together with the basis on which it was taken, including appropriate references to Governing Body papers. The decisions are reproduced in full, with the exception of those relating to reports of the Committee on Freedom of Association, where a simple reference is made to the paragraphs of the report that form the basis of the decision.

The table of contents is in the form of a detailed agenda showing for each item the number of the relevant Governing Body paper and that of the relevant paragraph in the Record of Decisions.

First item on the agenda

Appointment of the Director-General

- **1.** In accordance with article 17 of the Standing Orders of the Governing Body and with the rules adopted by the Governing Body at its 240th (June 1988) Session, a vote by secret ballot was conducted.
- **2.** The result of the vote was as follows: the required majority was 29 votes; Mr. Somavia obtained 53 votes; there were three abstentions. Mr. Somavia was therefore re-elected for a period of five years, in accordance with the ILO Staff Regulations, to the post of Director-General of the International Labour Office. The mandate of Director-General will take effect on 4 March 2004, at zero hours.

3. The Governing Body approved the minutes of its 285th Session. (First sitting, GB.286/2, paragraph 2.)

Third item on the agenda

Agenda of the 2005 sessions of the International Labour Conference

(a) Date, place and agenda of the 93rd Session (June 2005) of the International Labour Conference

- **4.** The Governing Body decided that the 92nd Session (2004) of the Conference should open on Tuesday, 7 June 2005, and that it should be held in Geneva. (First sitting, GB.286/3/1, paragraphs 1 and 2.)
- **5.** The Governing Body also noted that in addition to the items placed on the agenda of the Conference, and taking account of the second discussion of a comprehensive standard (a Convention supplemented by a Recommendation) on work in the fishing sector, it was invited to choose two additional items to complete the agenda of the 93rd (2005) Session of the International Labour Conference.
- **6.** In order to be able to take this decision in the light of the results of the first general discussion based on an integrated approach, to be held at the 91st Session (2003) of the Conference, the Governing Body decided to postpone the choice of the two items to

complete the agenda of the 93rd (2005) Session of the Conference until its 288th (November 2003) Session. (First sitting, GB.286/3/1, paragraph 18.)

(b) Preparatory Technical Maritime Conference (2004) and the date, place and agenda of the 94th (Maritime) Session (2005) of the International Labour Conference

- **7.** The Governing Body decided:
 - (a) that a preparatory technical maritime conference:
 - (i) be held in Geneva in September 2004;
 - (ii) would consist of tripartite delegations from all interested member States of the Organization, each delegation being comprised of one Government delegate, one Shipowner and one Seafarer delegate, together with such advisers as might be considered necessary;
 - (iii) would discuss, and make recommendations concerning, an instrument to consolidate maritime labour standards, on the basis of a draft to be submitted to it by the Office;
 - (b) that the Office shall, following the procedure set out in paragraph 4(b) of article 38 of the Conference Standing Orders, itself draw up, on the basis of the work of the preparatory technical conference, the final report to be communicated to governments in accordance with paragraph 2 of that article;
 - (c) that a Maritime Session of the International Labour Conference be scheduled for 2005, in addition to the regular June 2005 session, with the precise date and place being decided upon finally at a subsequent session of the Governing Body;
 - (d) to place on the agenda of the Maritime Session of the Conference, with a view to a single discussion, the adoption of an instrument to consolidate maritime labour standards.

Fourth item on the agenda

Review of annual reports under the follow-up to the ILO Declaration on Fundamental Principles and Rights at Work

- **8.** The Governing Body:
 - (a) examined the Expert-Advisers' Introduction;
 - (b) took note of the recommendation contained in paragraph 28 of the Introduction to allocate sufficient regular budget resources for the effective implementation of the 1998 Declaration by headquarters and field units;

- (c) appealed to donors for substantial and durable extra-budgetary support for ILO technical cooperation to meet the high demands expressed by governments and employers' and workers' organizations in countries not having ratified all core Conventions;
- (d) invited the Director-General to:
 - (i) continue to respond through contacts at the highest level to indications of emerging willingness on the part of governments that are not yet close to realizing the Declaration's principles and rights at work;
 - (ii) convene regional or subregional workshops among countries not having ratified all core Conventions for advocacy and reporting purposes and to enable them to share experiences with regard to progressing along the path charted by the Declaration;
- (e) draw the attention of international employers' and workers' organizations to the need to reinforce their collaboration with the Declaration programme, notably by providing their own comments and by encouraging national organizations to do the same.

- **9.** The Governing Body requested the Director-General:
 - (a) to draw to the attention of governments of member States in the Americas and, through them, to the attention of national organizations of employers and workers, the conclusions adopted by the Meeting;
 - (b) to take these conclusions into consideration when implementing current programmes and in developing future programme and budget proposals;
 - (c) to transmit the text of the conclusions:
 - (i) to the governments of all the member States and, through them, to national organizations of employers and workers;
 - (ii) to interested international organizations, including international non-governmental organizations with consultative status.

- **10.** The Governing Body thanked the Liaison Officer for the work she had done under difficult circumstances and took note of the information supplied in the documents.
- 11. The Governing Body noted with great concern that the plan of action proposed by the Government of Myanmar, and figuring in Appendix 1 of document GB.286/6/1, did not satisfy the minimum requirements set out by the Governing Body at its 285th (November 2002) Session to be acceptable.
- 12. Taking note of the desire expressed by the Myanmar authorities to continue the discussions in good faith, the Governing Body invited them to adopt before the opening of the Conference on 3 June 2003 a plan of action satisfying the urgent requests it formulated at its 285th Session, in particular concerning the appointment of a facilitator/mediator and the functions that such an appointment would have, as well as concrete measures to prohibit forced labour applicable to the "region of special interest for cooperation between the Government of the Union of Myanmar and the ILO".

Treatment of surpluses – Amendments to the Financial Regulations

23. The Governing Body decided to submit to the International Labour Conference, for adoption at its 91st Session (June 2003), the following draft resolution amending the Financial Regulations:

The General Conference of the International Labour Organization,

Recognizing that amendments to the Financial Regulations are required to ensure that surpluses are dealt with in an appropriate manner;

Decides to make the following amendments to the Financial Regulations:

Article 11

[...]

9. The Director-General shall transfer the surplus referred to in article 18.3, to a Special Programme Account, which shall be used, subject to the authorization of the Governing Body, to finance high-priority activities of limited duration that were not otherwise provided for under the budget adopted by the Conference and that do not create any expectation of additional future funding.

Article 18

- 1. (No change)
- 2. The amount of any surplus resulting from an underspending of the approved or amended budget, expressed in Swiss francs calculated at the budget rate of exchange for that financial period, shall be used to reduce the contributions of Members in the following way:

Members which paid their ordinary contributions in the financial period in which this surplus accrued shall have their share of the surplus deducted from their contributions assessed for the second year of the succeeding financial period; other Members shall not be credited with their share until they have paid the contributions due from them for the financial period in which the surplus accrued. When they have done so, their share of such surplus shall be deducted from their contributions assessed for the first year of the next financial period for which a budget is adopted after such payment.

3. The amount of any surplus resulting solely from the receipt of contributions in excess of the level of the budget as adopted by the International Labour Conference or as subsequently amended by the Governing Body, net of any reimbursements to the Working Capital Fund or other borrowings, shall be transferred to the Special Programme Account as defined in article 11.9.

Premises for the Regional Office for the Americas (Lima)

26. The Governing Body confirmed its wish for a more modern use of the building which would take account of the architects' recommendations, specifically with regard to safety and health aspects. Master plan for the "Jardin de Nations" area and site plan for the "Campagne du Grand Morillon"
